ORDINANCE 08-272

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF
MISSION VIEJO, CALIFORNIA AMENDING SECTION
2.04.050 OF THE MISSION VIEJO MUNICIPAL CODE

The City Council may, pursuant to Section 36516 of the California Government Code, increase its compensation by five percent (5%) on an annualized basis.

The City Council desires to apply the statutorily authorized authority. This results in an increase of Five Hundred Dollars (\$500.00) in compensation to the Councilmembers.

The City Council of the City of Mission Viejo does ordain as follows:

Section 1. Section 2.04.050 of the Mission Viejo Municipal Code shall be repealed and replaced with revised language that shall read as follows:

“Sec. 2.04.050. Compensation; reimbursement.

“The compensation for city council members shall be \$1,000.00 per month. Such compensation shall be payable at the same time and in the same manner as salaries are paid to other officers and employees of the city. When approved by the city council, each member of the council shall receive reimbursement for actual and necessary expenses incurred in the performance of official duties for the city, pursuant to law and city policies.”

Section 2. This ordinance shall be effective and applied pursuant to California Government Code Sections 36516 and 36937.

Section 3. The City administrative personnel are directed and authorized to undertake and accomplish all necessary budget, accounting, administrative or other actions necessary to effectuate this ordinance without further action by this City Council. This ordinance is intended to be a comprehensive action that authorizes all related actions to occur in the ordinary and routine manner without further City Council review or approval.

Section 4. The City Clerk is directed to certify to the passage and adoption of this interim ordinance and to cause the same or a summary thereof to be published and posted in the manner required by law.
